- Guest Coach privileges will be revoked if for any reason Skate Canada membership is suspended.
- I am participating as a Guest Coach at the discretion of the Director of Skating for Calalta FSC.
- I understand that Coaches under contract with Calalta FSC have priority on sessions.
- I understand that as a Guest Coach, my only access to registered Calalta skaters is through permission from the registered skater's primary coach.
- I understand that any conduct contrary to Skate Canada Coaching Code of Ethics or any of Calalta FSC policies will result in loss of privileges at Calalta FSC.
- I understand that teaching on Calalta FSC Ice is a privilege granted by the Director of Skating and the Board of Directors and may be restricted or revoked for failure to comply with any club/coaching regulations.

Contract Terms

1. Independent Contractor:

The Director of Skating acknowledges that the Guest Coach has been retained solely to provide the service described herein. In such capacity, the Guest Coach shall act solely as an independent contractor, and this Agreement shall not be construed as creating any employment contract, partnership, joint venture, or other relationship or association between the Guest Coach and the Calalta FSC. As such, the Guest Coach is responsible for all income, and appropriate employment deductions relating to the Guest Coach's services hereunder. Further, the Guest Coach is entitled to make such arrangements for coaching lessons as the Guest Coach sees fit, subject to the Calalta FSC's policies, procedures, rules, and regulations.

2. Indemnity:

The Guest Coach hereby indemnifies and holds harmless Calalta FSC, City of Calgary and Winsport and its trustees, officers, employees, agents, successors, and assigns from and against any claim, action, cause of action, loss, damage, cost, expense, judgment, or other liability of any kind (including without limitation reasonable attorney's fees and disbursements) of any person arising out of or in connection with, directly or indirectly, the services of the Guest Coach under this Agreement.

3. Disclaimer and Waiver of Liability:

The Calalta FSC, City of Calgary, WinSport and/or their agents, assume no responsibility for accidents, injuries or loss however caused and the applicant agrees to release the proprietors from all claims and/or damages arising as a result of such accidents or losses.

4. Release:

The Guest Coach hereby acknowledges and agrees that the Guest Coach assumes all risk of accidental injury or other claim that may arise from the Guest Coach's services hereunder or as a participant in any of the Calalta FSC's programs, and on behalf of the Guest Coach and the Guest Coach's heirs, executors, and administrators, hereby releases, discharges, acquits, and forgives the Calalta FSC, City of Calgary and Winsport and/or its agents, trustees, officers, employees, agents, successors, and assigns from any and all liability for damages of every kind and nature arising out of such services and such participation.

5. Guest Coach Policy:

The Guest Coach hereby acknowledges and agrees to abide by the Policy as set out by Calalta FSC and agreed to in the application form.

6. Binding Nature:

This Agreement shall be binding upon the signatures of the President and Director of Skating of the Calalta FSC and the Guest Coach.
